Dear Mayor Akinjo and City Council,

I am writing to follow up on my formal request dated March 23, 2026, regarding the free Community Bike and Traffic Safety Education Event planned for Saturday, May 17, 2026, at the City Hall parking lot.

Given that the lack of public awareness on California's yield laws and distracted driving remains a documented public safety crisis on Lathrop streets, we are eager to move forward with planning. We are actively organizing community support, with Lathrop families signing our letter urging the City's approval.

We are actively securing partnerships with organizations such as Safe Kids San Joaquin County and the

San Joaquin Bike Coalition, who have been invited to co-present the event. Connecting with a City representative to discuss logistics and permitting is the critical next step required to finalize these external partnerships and move forward with the event.

Could you please connect me with the appropriate city staff member (e.g., Parks & Recreation or City Clerk's office) to begin the permit process immediately? Additionally, as the April 13 council meeting approaches, I would appreciate confirmation on whether I will have the opportunity to speak before the Council regarding the event logistics, as I offered in my initial correspondence.

Thank you for your attention to this urgent safety matter.

Dear Mayor Akinjo,

My name is Torie Cortez. I am the publisher of Dismal Freedom Press, an independent newsroom covering education, civil rights, and community issues across the Central Valley — and I am also a Lathrop-area parent. We have had the pleasure of meeting you at a community holiday event, and I have a great photo of my whole family with you from that day. I would be happy to share it if you would like a reminder of the occasion.

I am writing to formally request that the City of Lathrop host a free, family-oriented Bike and Traffic Safety Education Event in the City Hall parking lot during May 2026, in recognition of National Bicycle Safety Month.

This is not simply an event about wearing helmets. This is about the law — and the fact that too many drivers in our community do not know it, and too many cyclists and families do not know their rights under it.

Under California law, drivers must yield to cyclists and pedestrians at driveways (CVC § 21804). Cyclists have the same rights and responsibilities as motor vehicle operators on public roadways (CVC § 21200). Distracted driving is a criminal infraction. These are not obscure rules — they are the law — and the gap between what the law requires and what is happening on Lathrop streets is putting children in danger.

I am writing this letter because my family has lived that danger firsthand. I have personally been nearly struck by vehicles four times while riding with my children this spring. More urgently: within the last 30 days, my daughter Camryn was nearly struck by a distracted driver who failed to yield while exiting the driveway at Mossdale Landing Elementary School during after-school program hours.

The children who witnessed this incident were students enrolled in the after-school program — students who were unsupervised at the time because the staff member responsible for supervising them was not present with them. It was only when I began shouting in response to the near-miss that the staff member came outside. I have filed a formal complaint with MUSD regarding this supervision failure and am placing the driveway safety conditions at Mossdale Landing on record with the City.

The event I am requesting would address these gaps directly. Proposed programming:

- Driver education on California's yield laws at driveways and bike lanes (CVC §§ 21804, 21950)
- Cyclist and family education on rights of way, hand signals, and road rules
- Distracted driving awareness
- Free helmet fittings and safety gear distribution
- A kids' bike skills course in the parking lot
- Tabling by Safe Kids San Joaquin County (SJC Public Health, (209) 468-2699) and the San Joaquin Bike Coalition
- Participation from Lathrop PD community outreach

This event would require no city budget beyond the use of the parking lot. Dismal Freedom Press would provide full editorial coverage, giving the City a visible, community-facing story to share with residents.

You have spoken publicly about the importance of safe infrastructure for children who bike and walk in Lathrop. This event is an opportunity to demonstrate that commitment at zero cost — before a child in our community is seriously hurt.

I would welcome the opportunity to speak at the April 13 council meeting or to connect with the appropriate city staff member regarding logistics and permitting. I can be reached at this email address or by phone.
